

# **iProjex API service**

## **1. Introduction**

The iProjex API service objective is to allow machine-to-machine interaction for the submission of the following files to CCMC:

- National implementations
- National titles
- ICS (DIN)
- TC titles (DIN, AFNOR)
- Infopro data
- Keymark data (DIN certco)
- Normative references (DIN)
- Third countries national implementations

## **2. API interface (human interface)**

This interface to the iProjex REST APIs allows a consumer to understand and interact with the remote service in a simple way without any coding.

## **3. Authentication**

For machine-to-machines, Basic authentication is base64-encoded username:password.

## **4. File submission**

The XML files with the submitted using the POST method as describe below.

## **8. Log file - description**

The log file returned (see 7.) will be similar to the log files returned by the application, but will contain the following additional information:

- In addition to the “message description” (<Description>), the log file will also contain the “message code” (<Code>) to facilitate the further automation of the handling of errors (see annex 1 – can be provided in XML)
- A new status code (<StatusCode>,<StatusCodeDescription>) will also facilitate the global assessment of processing of a set of data
  - o Status code: 1000 description: ALL records uploaded/validated
  - o Status code: 1100 description: Records uploaded/validated partially
  - o Status code: 1200 description: NO records uploaded/validated
