

Background

- December 2015: CEN & CENELEC BTs set up CEN-CENELEC BT WG 9 'Strategy for the construction sector' with the task to prepare the CEN-CENELEC 'Position Paper on the implications of the Construction Products Regulation on the European Standardization System
 - Allocating the convenorship to BSI and appointing Duncan King as Convenor
- August 2016, CEN and CENELEC BTs extended BT WG 9 lifetime due to the broadening of its scope and activities, in particular its contribution to JIS Action 5 'Aiding the implementation of the Construction Products Regulation (CPR) through standards'.
- November 2019, CEN and CENELEC BTs extended BT WG 9 lifetime to the end of 2020 and approved the revised terms of reference



CEN-CENELEC BT WG 9 'Strategy for the construction sector'

Objective:

- To provide ad-hoc support to CCMC and Technical Bodies in aspects related to the development of harmonised European Standards (hENs) in the framework of the Construction Products Regulation (CPR).
- Acts as an advisory and coordinating body on horizontal and strategic matters related to the CPR, under the CEN and CENELEC Technical Boards.



CEN-CENELEC BT WG 9 'Strategy for the construction sector'

Objective:

- Contributing to the European Commission 'Joint Initiative on Standardisation under the Single Market Strategy' Action 5 'Aiding the implementation of the CPR through standards' activities;
- Developing guidance for the elaboration of hENs under the CPR;



CEN-CENELEC BT WG 9 'Strategy for the construction sector'

Objective:

- To advise CEN and CENELEC Technical Boards (BTs) on the implications of the CPR regarding standardisation activities;
- To provide input into Standardization Requests (formerly called Mandates) having a horizontal outlook, on behalf of CCMC



Membership:

- Convenorship appointed by CEN and CENELEC BTs;
- Secretariat (provided by BSI);
- CEN-CENELEC Management (CCMC) staff;
- Members: the group will be open to CEN and CENELEC BT members, who shall act as a focal point for their respective national interests and ensure full consultation of stakeholders, with a limit of one representative per organization;



Membership:

- Nominated expert(s) from interested CEN and CENELEC Partner Organisations, as per <u>CEN-CENELEC Guide 25</u> The concept of Partnership with European Organisations and other stakeholders, with a limit of one representative per organization;
- At the Convenor's discretion, other persons with an interest in items under discussion may be invited to participate.



Activities:

- Communicating information on CEN and CENELEC standardisation activities and best practices under the CPR;
- Promoting deliverables of JIS Action 5;
- Reporting regularly on standardisation activities under the CPR to the CEN and CENELEC Technical Boards, at least once per year;
- Developing guidance to address specific aspects of the CPR, as and when is needed.
