# **Technical & Governance committees**

### SD Documents – Status + Figures



Technical committees

- ► Migrated since May 2021
- ▶2063 committees (active and dormant)
- ▶845.000 documents
- Governance committees
  - ► Migrated since April 2022
  - 61 committees: 37 Governance committees and 24 Sector committees (Sector Fora's, Focus Groups, Coordination Groups),
     55.000 documents

### Remaining committees:

Currently finalizing the migration of the disbanded committees and some other remaining groups still hosted at DIN and AFNOR

### SD Documents – Main benefits



- Common environment for all CEN, ISO and national committees
- Clear and transparent permission model (GD role-based access control)
- Controlled numbering system for most committees (N-number)
- Greatly enhanced Document search tool
- For the governing bodies, possible future integration in the CEN ecosystem (e.g: Meeting registration)
- SD Documents is evolutive. ISO is constantly working on new features

### Standardization Requests

Request from the European Commission to the ESOs to develop one or several standards to support the EU legislation or public policies.
 Groups are created to discuss these requests
 Target: committees in a new tenant in SD Documents

### Citation in OJEU

Publication in which all tenders from the public sector which are valued above a certain financial threshold according to EU legislation, must be published.

Target: a library of support documentation in SD Documents

### Cost Control Platform

- Communication platform for specific agreements or order vouchers
- All new contracts are on a EC platform. CEN keeps all projects prior to 2022.
- Target: evaluation of 2 potential hosting platforms

### Livelink Archives

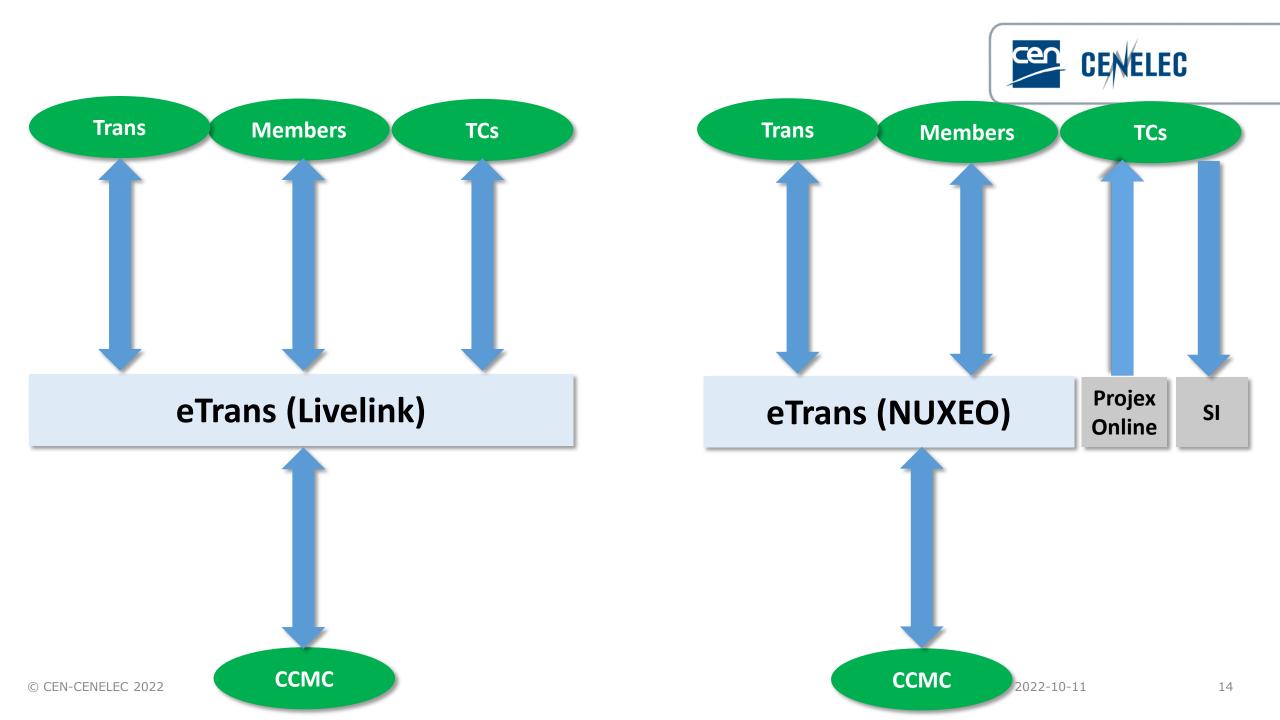
- The archiving of the different platforms hosted on CEN/TC were based on different criteria determined by the business internally.
- Each platform will be migrated in a zip File containing 2 files:
  - $\circ$  one zip file with all the files
  - $\circ~$  one file with all the metadata
- Documents will be available on request only

### Approach - Platform

- Stay as close as possible to the ISO solution (ISO ICE)
- Distribution channel with members (TCs will use other channels)
- No change in the **translation process**



### Approach - Platform

- Structure based on **work item ID** instead of TC
  - ✓ Stable location for project folder from its initial creation (WIID)
     ✓ Unambiguous relation between a document and the related WI
     ✓ Same navigation as in ISO
- Same **ZIP files and filename conventions** (Note: Moving towards standalone files (word, PDF, XML) will be considered later)

Approach - Migration

- Migration of all the complete collection of formal documents (stable delivery enquiry, enquiry draft, vote draft, published) in all available formats (Word/PDF, XML)
- Migration of the **working documents** (first delivery, stable delivery vote, translations) being currently processed in all available formats (Word/PDF, XML)
- No migrations of the former versions (technical versioning) of a given document; Only the latest version is migrated.



### Approach – Translation process

- The eTrans NUXEO <u>test platform</u> will be opened to the translators (AFNOR, BSI, DIN, DKE) so that they can start assessing the specific translation features (specific search tool, document upload, ...)
- A message will be sent to the translators the week of 2022-10-10 to inform them
- Testing period of **2 weeks**
- The feedback will be discussed in a meeting when relevant



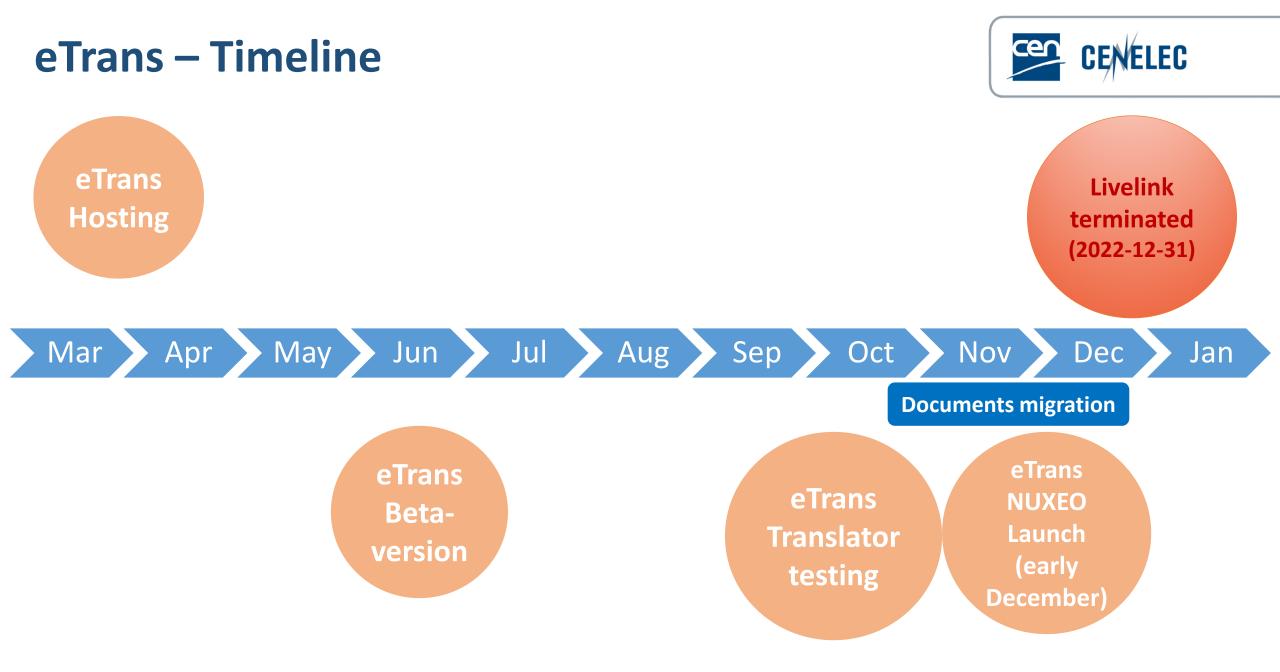
### **Approach - Migration**

- The existing publication IDs (former Livelink ID) will be kept in the new platform:
  - $\checkmark$  No change in the definition of the ID Number (15)
  - $\checkmark$  No change in the URN of the Release Items provided in the HAPI
  - ✓ No change in the URL of the documents provided in the PROJEXDATA feeds



### Approach - Migration

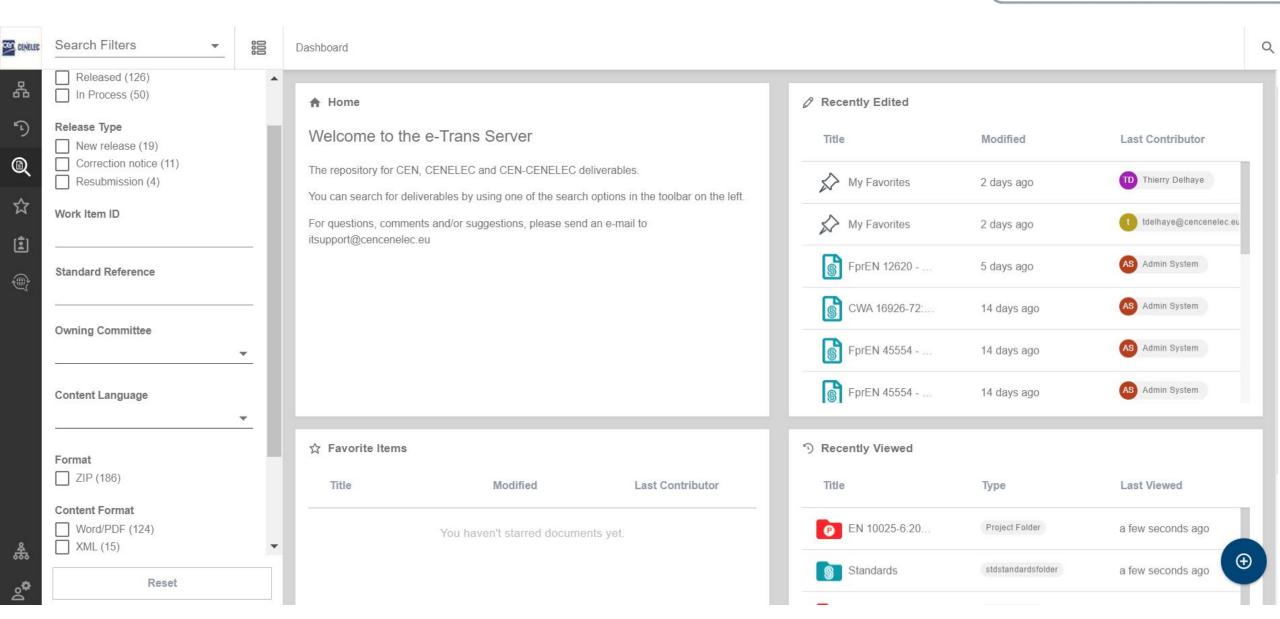
- The launch of **new eTrans on NUXEO** is planned **early December** (final date to be confirmed)
- When launched the **former eTrans on Livelink** is not meant to be used anymore; However, for technical reasons, access cannot be removed or the access to the platform cannot be blocked until 2022-12-31
- The migration of the documents will start in October and is likely to take several weeks. It is therefore possible that the entire standards portfolio is not yet migrated at the time we launch the new platform.



  - PROJEXDATA Events: new URLs available from 2022-10-14
