Webinar for CENELEC TBOs - New process for the approval of NWI, including TS & TR Questions & Answers

1	Does the link to dashboard is already visible in https://experts.cenelec.eu/ ?	It is not visible yet, but it will appear before the tool goes live.
2	Can JTC secretaries also use this system?	No. CEN and CENELEC BT Permanent Delegates have still to discuss the extension of the process for JTCs
3	Is there any plans to extend this to SCs?	Secretaries of Subcommittees do not have access to the tool because the creation of NWI is to be approved by its parent Technical Body, who in turn uploads the request on the tool.
4	In the box 'new Revision', shall we insert the base document (IEC endorsement) or the base document + its AMs?	Selecting the main standard / base document is sufficient because the amendments relate to this old version.
5	Is it correct, that NWI is to be submitted to CCMC via the tool solely by a TC Secretary?	For a TC, like today, the Secretary and Assisting Secretary can submit NWIs to CCMC.
6	Before sending the NWIP to CCMC the TC should approve it, right?	No, the new system is exactly implemented in order to allow a TC decision, which will be the final decision (in eVoting). No longer preliminary approval via CIV or at the meeting
7	How about outlines as add on to the NWIP?	
8	Will the ones already submitted to BT directly and in a pipeline for approval be transferred onto this platform from March too? Or will they carry on staying in the old format/system? Especially for those created as PWIs.	The new process applies to all NWIs launched for approval as of 7 March 2024. If PWI are to be activated as NWI after the 7 March 2024, the new system can be used.
9	The TC secretary will receive an automatic email when BT will approve the NWI?	With the new NWI process the BT will not approve any longer the NWI. The system sends automatic notification to those identified as voters



10	If the TC introduces them in the system at the same time, will the ballot start at the	It depends when CCMC PM will validate the NWIs. The PM validation triggers the creation of the ballot in eVoting. TC secretaries should fill out the NWI online tool with all WIs and sensitise CCMC PM that
	same time?	validation of all related WIs should go together.
11	I have recently launched a CIV asking the TC members whether they agree to seek BT permission to create a new edition of an existing EN 50xxx standard. The closing date for this CIV is after 7 March. So after 7 March do I still have to go for BT permission or can I just use the new process to create the NWI? So after 7 March do I still have to go for BT permission or can I just use the new process to create the NWI?	The new process applies to all NWIs launched for approval as of 7 March 2024. Then, in theory those NWIs should be submitted to BT for final approval. They follow the current process. If TC agrees, the CIV outcome can be neglected and
12	For NWIs currently I circulate a Q document PDF with a document number to the TC via the collaboration platform for initial TC approval before submitting the result to CCMC for BT approval. I assume now we do not need to circulate NWI to the TC via the collaboration platform?	Exactly, this new process is a huge simplification. It is no longer needed to use the NWI form in Word and save it in CP, but just to access and use the new CLC online tool.
13	Do I have, as Sub-committee secretary all rights on the tool or do I need to ask my parent committee secretary to do something for me?	Secretaries of Subcommittees do not have access to the tool because the creation of NWI is to be approved by its parent Technical Body, who in turn uploads the request on the tool.
14	The eVoting tool presented today refers solely to NWIs. Is this to be answered by NCs, the CENELEC Members?	Voters in that CLC/TB as identified in EMS
15	Adoptions of published IEC/TSs & IEC/TRs are included in this process?	Yes, they are.
