## Inclusiveness of the ESS



► An Inclusive CEN and CENELEC System to be the preferred choice for standardization in Europe is one of the 5 goals identified in the CEN and CENELEC Strategy 2030



▶ Participation of Societal Stakeholders and SMEs in European standardization, complementing their participation at national level → Specific partnerships with CEN and CENELEC

- ► CEN-CENELEC commitment to inclusiveness reinforced by
  - ► EU Regulation 1025/2012 on European Standardization
  - **► EU Standardization Strategy** (2022)

#### ANNEX III

#### EUROPEAN STAKEHOLDER ORGANISATIONS ELIGIBLE FOR UNION FINANCING

- 1. A European organisation representing SMEs in European standardisation activities which:
- (a) is non-governmental and non-profit-making;
- (b) has as its statutory objectives and activities to represent the interests of SMEs in the standardisation process at European level, to raise their awareness for standardisation and to motivate them to become involved in the standardisation process;
- (c) has been mandated by non-profit organisations representing SMEs in at least two thirds of the Member States, to represent the interests of SMEs in the standardisation process at European level.
- 2. A European organisation representing consumers in European standardisation activities which:
  - (a) is non-governmental, non-profit-making, and independent of industry, commercial and business or other conflicting interests;
  - (b) has as its statutory objectives and activities to represent consumer interests in the standardisation process at European level;
  - (c) has been mandated by national non-profit consumer organisations in at least two thirds of the Member States, to represent the interests of consumers in the standardisation process at European level.
- 3. A European organisation representing environmental interests in European standardisation activities which:
- (a) is non-governmental, non-profit-making, and independent of industry, commercial and business or other conflicting interests;
- (b) has as its statutory objectives and activities to represent environmental interests in the standardisation process at European level;
- (c) has been mandated by national non-profit environmental organisations in at least two thirds of the Member States, to represent environmental interests in the standardisation process at European level.
- 4. A European organisation representing social interests in European standardisation activities which:
- (a) is non-governmental, non-profit-making, and independent of industry, commercial and business or other conflicting interests;
- (b) has as its statutory objectives and activities to represent social interests in the standardisation process at European level;
- (c) has been mandated by national non-profit social organisations in at least two thirds of the Member States, to represent social interests in the standardisation process at European level.

- Consulted by the EC on its AUWP and environmental matters.






- Participate in TCs (Obs.) and WGs (Exp.) without the need to request a liaison.

Figure 1: Issuing standardisation requests – overall workflow<sup>8</sup>



# What are Gender-Responsive Standards?



A gender-responsive standard:

- Reflects an understanding of physical differences and gender roles of women and men;
- Integrates diverse physical and social/cultural dimensions within the design and performance of the product, process, or service being standardized;
- Equally addresses the needs, experiences, and concerns of all users, incl. women, men, girls and boys;
- ► Ensures the standard provides the same outcomes for and equal benefit to all.



# Why do Gender-Responsive Standards matter?



International

Women represent half of the world's population and contribute to 37% of global GDP. Studies show gender equality positively impacts GDP.

Standards are not protecting women as well, as they benefit men.

In some cases, standards further disadvantage and/or even harm women.

# GRS case study: The case for Anthropometric diversity



Standard on measurement of thermal insulation by means of thermal manikins (EN ISO 15831:2004)



Standard on manual handling of machinery (EN 1005-2:2003+A1:2008)



# Case 1: Measurement of thermal insulation by means of thermal manikins



- Standard describes the requirements (size and shape) of the thermal manikin and the test procedure
- ► Manikin shall be  $(1.70 \pm 0.15)$  m, with a body surface area of  $(1.7 \pm 0.3)$  m<sup>2</sup>
  - ▶ Quite large range of diverse body sizes, but....
  - ► The standard does not consider different body shapes and child body sizes
  - ▶ Industry prefers male body shape, because of comparability of test results
  - ▶ No references to anthropometric database or study

Question: what could be done in the standardization process to make standards like this one more inclusive?

# **Case 2: Manual handling of machinery**



- Standard provides ergonomic recommendations for the design of machinery involving manual handling, including horizontal and vertical positioning
- Vertical: ideal height is 75 cm, maximum is 175 cm

- Recommended height is based on anthropometric data from:
  - ▶ Subjects from USA army adult men
  - ▶ Data from 1960-1980

Question: What issues could arise from using that data set?

# Gender-Neutral vs. Gender-Responsive



#### **Neutral**

- Generic One-Size-Fits-all
- Assumption the end user is by default a man
- Missed gender implications
- Lack of population representative datasets (anthropometrics)
- Lack of inclusive language (deliverable)

## Responsive

- Explicit consideration of gender differences
- Men and women equally benefit
- Representative datasets (anthropometrics)
- Inclusive language (deliverable)

# 7 Steps to ensure European Standards are Gender-responsive?



- 1. Assess the diversity of knowledge, experience and stakeholders in Technical bodies and consider different needs
- 2. **Increase** representation of women in TCs/WGs
- 3. **Understand** we all carry biases. A gender-balanced TC/WG does not equal to gender expertise, nor does it automatically guarantee GRS
- 4. **Promote** an inclusive environment that allows equal participation
- 5. **Consider** the implications of gender differences even if not obviously related.
- 6. **Assume** there are gender differences that will have implications
- 7. **Use** representative and sex-disaggregated data (incl. Up-To-Date data)



# 2. Guidance to foster inclusive drafting processes & environments: what role do you have to play?

## How to foster inclusive standarddrafting processes & environments



It's **everybody's responsibility** to cultivate an inclusive approach to standardization

- Promote a professional culture in all interactions
- Ensure rules & process are observed to guarantee transparency, openness and smooth processes
- Proactively look for diverse inputs and support equal opportunities for the participation of all stakeholders
- Check your own biases and behaviors
- Use respectful and inclusive language
- Speak up if something is not sitting right with you
- Use the **tools** at your disposal and embedded in CEN-CENELEC System to ensure enhanced participation of all stakeholders

#### Code of Conduct for delegates, experts and observers participating in the technical work of CEN/CENELEC

Delegates, experts and observer participating in the technical work of CEN/CENELEC are aware of CEN/CENELEC Internal Regulations and Guides, especially

- the CEN-CENELEC Common Policy on Patents (and other statutory intellectual property rights based on inventions) as laid down in CEN-CENELEC Guide 8;
- . the provisions regarding competition law as laid down in CEN-CENELEC Guide 31; and
- the CEN-CENELEC Policy on dissemination, sales and copyright of CEN-CENELEC Publications as laid down in CEN-CENELEC Guide 10.

Delegates, experts and observers shall contribute to the work of CEN/CENELEC in accordance therewith.

Delegates, experts and observers participating in the technical work of CEN/CENELEC shall recognize the following principles and behave in accordance therewith:

- Work for the net benefit of the European community: Delegates, experts and
  observers recognize that the development of European Standards or other European
  standardization deliverables is for the net benefit of the European community.
  Delegates, experts and observers are committed to advancing European Standards
  or other European standardization deliverables within their agreed scope and we will
  not hinder their development.
- Uphold consensus and governance: Delegates, experts and observers uphold the key principles of international standardization: consensus, transparency, openness, impartiality, effectiveness, relevance, coherence and the development dimension.
- Agree to a clear purpose and scope: Delegates, experts and observers are committed to having a clear purpose, scope, objectives and plan to ensure the timely development of European Standards or other European standardization deliverables.
- Participate actively and manage effective representation: Delegates, experts and
  observers agree to actively participate in standards development projects. Delegates
  and experts make their contributions to the work through the official procedures in
  accordance with the CEN/CENELEC Internal Regulations.
- Escalate and resolve disputes: Delegates, experts and observers identify and escalate disputes in a timely manner to ensure rapid resolution. Delegates, experts and observers uphold the agreed dispute resolution processes.
- Behave ethically: Delegates, experts and observers act in good faith and with due
  care and diligence. Delegates, experts and observers avoid collusive, anticompetitive
  or dominant behaviour. Delegates, experts and observers promote a culture of fair
  and ethical behaviour.

Respect others in meetings: Delegates experts and observers are committed to respecting others and the professional culture of European standardization within CEN/CENELEC. In meetings delegates, experts and observers are committed to:

- · Conducting themselves in a professional manner
- · Respecting others and their opinions
- Revealing neither the identity nor the affiliation of other participants when using information received but not included in official minutes without prior consent
- Accepting decisions of the CEN/CENELEC Technical Board and the respective Technical body they are participating or its parent Technical body
- Ensuring that the views of all (including those whose first language is not that
  of the meeting) are heard and understood.

Should a delegate, an expert or an observer demonstrate an undue behaviour the Chair resp. the Convenor shall remind him/her. Should the undue behaviour reappear the Chair resp. the Convenor shall inform the CEN/CENELEC national member having appointed this delegate/expert or the Partner/Liaison Organization having appointed this observer accordingly and immediately.
