1 Purpose

This document is intended to complement the [iPROJEX General User Guide](#) which explains:

- how to use the iPROJEX tool
- the different steps to perform when using iPROJEX (common to all modules)

The aim of this documentation is to give you detailed information on the Keymark Data module (XLS format):

- detailed information on the XLS file structure (field names, description...)
- explanation of all error and warning messages (displayed on the screen or included in the log files)

2 Introduction to the business area

Data concerning Keymark certificates (and related product and production site information) and certified companies (manufacturers, suppliers) are maintained by the Certification Bodies¹ and delivered to CCMC via datafiles using iPROJEX.

3 XLS file structure

Take a copy of the template and save it under a different name.

The XLS file is composed of one sheet named **CERTIFICATE**.

Important notices:

- Do not rename, move or remove any sheet or field!
- The file type has to be .xls not .xlsx

3.1 Data fields

3.1.1 Header info

The header is composed of the following fields:
