1 Purpose

This document is intended to complement the [iPROJEX General User Guide](#) which explains:

- how to use the iPROJEX tool
- the different steps to perform when using iPROJEX (common to all modules)

The aim of this documentation is to give you detailed information on the ‘Translation prior FV’ module (XLS format):

- detailed information on the XLS file structure (field names, description...)
- explanation of all error and warning messages (displayed on the screen or included in the log files)
- reminder files criteria

2 Introduction to the business area

In the framework of the revised Formal Vote procedure (cf decisions CEN/BT 44/2015 and CENELEC D 152/028), the NSBs responsible for the provision of the translation of the European standards are requested to inform CCMC if they intend (or not) to translate before the launch of the Formal vote.

3 XLS file structure

The XLS file is composed of one sheet named ‘**TRANSFV**’ .

Important notices:

- Do not rename, move or remove any sheet or field!
- The file type has to be .xls not .xlsx

Hints:

- The easiest way to create an Excel file with the correct format is to use the **Generate Reminder file** facility of iPROJEX, selecting XLS as the required format.
- Please use ‘Delete’ rather than ‘Clear cells’ in Excel to remove any unwanted rows.

3.1 Data fields

3.1.1 Header info

The header is composed of the following fields:

Name	Type	Description	Obligation
NSB	String	National member name. Examples: AFNOR, DKE, DIN	Compulsory
DATE	Date	Date and time the file was generated Example: 2016-08-01T11:49:17	Compulsory
VERSION	Integer	Version number = 1	Compulsory
EURKEY	Integer	The identification of the European Standard is clearly critical for the exchange of data. The data element EURKEY is used to indicate which key your organization is using. Values: 1 = WIID 2 = WIN 3 = EURREF Note: The Reminder file contains these 3 keys and the EURKEY is set by default to the WIID.	Compulsory

3.1.2 Translation prior FV information (tab ‘TRANSFV’)

This sheet contains information on the intention to translate or not before Formal Vote.

European standard reference	String	Examples: prEN 13565-2, prEN 12216	Compulsory if EURKEY = 3
W.I. number	String	Work Item number Examples: 00191285, 00033410	Compulsory if EURKEY = 2
W.I. surrogate	String	Identifier of the European standard CCMC database surrogate of the WI as provided in PROJEXDATA. Examples: 62301, 35648	Compulsory if EURKEY = 1
Responsible Technical Body	String	For information only.	Optional

Current Stage	String	Last realized milestone. For information only.	Optional
Plan 50.20	Date	Plan date 50.20.0000. For information only.	Optional
Translation prior FV	Integer	2 possible values: 1 (Yes) 0 (No)	Compulsory

4 Errors and Warnings

Reminder:

An **Error** is a problem which will prevent the data record from being loaded into the CCMC database.

A **Warning** does not prevent the data record from being loaded but should be noted and possibly investigated by the user.

4.1 Error messages
